Supervisor Masters suggested the comprehensive planners get involved in the development of the keyholing law. Town Attorney Bob DeMore suggested we continue the public hearing on November 5th at 6:15, and all agreed.

# **Financial Report**

Tom Chartrand reported on general spending which is at about 74% without the SOTS; general revenues are at 96%; highway spending is at 60% and revenues at 90%; ambulance spending is at 67% and revenue is nearly 100%. In addition, court fines are catching up at 61% right now.

In the general fund, we did receive a \$500 rebate from our Workers' Comp carrier. Our \$30,000 grant for the tennis courts came through.

#### Legal
