This past year it became necessary to repair the waterline due to pipe leaks. There is a need to replace mower/trailer equipment, which were purchased in 1996 and 2008. Our trimmers were purchased in 2004 and 2009.

# **Southern Knights Baseball Club Swings Wood Bats!**



PLEASE TAKE NOTICE that a public hearing will be held by the Tully Joint Planning Board on Thursday, August 27th, 2020 at 7:00pm in the Municipal Building located at 5833 Meetinghouse Road, Tully, New York, regarding site plan application of Blue Sky Towers III, LLC and Bell Atlantic Mobile Systems, LLC to construct and operate a 150' wireless telecommunications tower (with 4' lightning rod) and associated improvements on land owned by Theodore V. Shaw located at 449 State Route 281 in the Town of Tully, Onondaga County, New York. The tax parcel subject of this application is 107.02-4-1.
